# **Opening Remarks/Executive Committee Report**

A verbal affirmation of adherence to the GRSB Anti-Trust Policy was received from those on the call.

# **Consideration of Minutes**

It was moved by Werth and supported by Jensen that the minutes from the April 26, 2023 Board of Directors meetings be approved as presented. Motion carried.

#### **Communications Updates**

<u>GRSB Communications Webinar, May 24, 3:00 – 4:30 PM Central US/Canada time</u> – Peck reminded members to join today's webinar featuring two case studies from the Canadian Cattle Association and Beef and Lamb New Zealand who will be sharing respective communications tactics on approaching regulatory or policy issues.

Communicators Summit, October 2-3 in San Diego — Peck reported the Comms Council is still working on the details for the next Communicators Summit where they hope to amplify GRSB's communications efforts and empower roundtables and members with materials to share with their members. There will be panel discussions and breakout groups, as well as ample opportunities for networking. One of the deliverables to achieve is a finalized Public Trust Research format that would allow for more consistent research on an annual basis around consumer perceptions on sustainability in the beef industry. All are invited as this is not exclusive to Communications Professionals; however, the primary audience is communications and marketing specialist.

<u>Tour Options</u> – Werth provided an overview of two full-day tour options on Monday, Oct. 2 to see beef production operations in San Diego and the Imperial Valley. Recommendations made were to ensure the tour ties in with GRSB's Communications objectives from the Summit, and allow for individual interaction with the facility host and not just spectate, and also constructively utilize bus time for discussions. Werth will provide an outline to be sent to the Board as a follow-up to inquire tour option preference.

Eric Mittenthal (NAMI) provided a brief overview of the Protein Pact Summit schedule, October 5-6, including an evening reception on Oct. 4. Cross-participation and partnership are hoped to be leveraged for both GRSB and the Protein Pact. Ambrose added GRSB and NAMI have a call scheduled on May 31 to discuss further joint integration opportunities.

#### **Working Group Updates**

<u>Animal Health & Welfare (AHW)</u> – Petre reported the next Animal Health and Welfare Working Group call will be on June 1 and discussions will include AHW project ideas to help advance the goals.

<u>Climate</u> – Werth reported the next Climate Working Group call will be on June 5 and include a presentation from Ceres Tag on some of their research work, as well as discussion on implementing a carbon scoping project.

Nature Positive Production (NPP) – Eisele announced that Hillary Fenrich has been contracted as an Independent Consultant to help GRSB continue the Nature Positive work alongside Eisele. They are working on restructuring the working group to include a core group, updating the Terms of Reference from three years ago, and developing an action plan for NPP deliverables for the remainder of 2023 and into 2024. The action plan is near completion and will be circulated for review in advance of the next NPP Working Group call. They will also be working with each of the roundtables to identify individual data and indicators currently available and how to aggregate the metrics at a global level. <u>Social Impact Goal</u> – McConnel reported that the drafting group is working in tandem with the full working group on various draft language options for updating the Principle and Criteria for People and the Community, as well writing the Social Goal. Wordsmithing to read as *guidelines* rather than *commitment* is key.

**Regional Roundtable Updates** – The Regional Roundtable reports are attached.

Petre reported that the monthly National Roundtable calls will be chaired on a rotational basis and each chair will be given opportunity to provide a National Roundtable Update on the Board calls going forward.

Hadarits chaired the last National Roundtable (NRT) meeting and provided an update that the roundtable agreed the monthly calls should be more strategic with specific objectives, actions and outcomes. Discussion included the need to understand the mutual needs of GRSB and the Roundtables, as well as from each other. This monthly call is well attended and is a great forum for working group leads to be part of the conversation. The NRT will be working on developing a work plan for the remainder of 2023.

#### **Executive Director's Report**

Petre reported on recent travels to include the U.S. Roundtable's General Assembly in Boise, Idaho which hosted interesting tours and speakers, and the Beef Breeders Forum in New Zealand which focused on sustainability and the important role of genetics.

Emerging Ag/CoP28, Dubai – Petre reported on the recent kickoff meeting with Emerging Ag in preparation for CoP28 which will be 12 days (Nov 30-Dec 12). Two particular days of interest for GRSB are on Nature, Land Use & Oceans, and Food and Water Systems. Food Systems and Agriculture will be a major part of this CoP and hopefully resulting in accord. FAO is building a roadmap toward 1.5°C with a pathway to reduce global greenhouse emissions, and GRSB would like to align with this. The Bonn Climate Change meeting is in Rome in June and virtual attendance is open; Emerging Ag, NWF, NAMI & USRSB will be present. Please let GRSB know if you would like to be art of the monthly group calls.

Monitoring and Reporting – Petre reported that SureHarvest is working on the reporting framework with feedback from the roundtables. GRSB can have its first attempt to gather reporting data from the roundtables. While not in a position to aggregate that data, we can formulate it in a useful and visually presentable dashboard to offer an overview of progress against the three goals in different parts of the world.

<u>Fundraising Needs</u> – Petre reported GRSB will be establishing a universal project fund that can support all project areas that would specifically provide GRSB members with support in contributing to reaching the Global Goals. One project idea is using consultants to conduct a scoping study around GHG reporting and

how GRSB can support its members to report in a consistent way across the many mechanisms that exist such as SBTi, Carbon Disclosure, etc. Each project would be presented to the Board for their input and direction. Fund contributors may specify project(s) for allocation. A flyer is currently being developed to outline this fund structure in more detail. Any input to this process is welcome.

Other project ideas suggested include: coordinate industry partnerships (i.e., FAO, Gleam, IICA, etc.) for the roundtables, and actions or partnerships that help the roundtables in achieving their goals as aligned with the Global Goals.

Eisele added Fenrich will also be helping to seek funding resources for the projects.

## **Regional Director's Report**

<u>Future of Food Innovation Forum</u> – Eisele reported having attended the Future of Food Innovation Forum in Amsterdam which was closely related to the food systems, as well as regenerative agriculture. The event was very anti-beef claiming beef cannot be sustainable. Eisele believes GRSB can strengthen its position by producing metrics and data showing beef can be sustainable, and having a presence at CoP28 will be important. Werth added it is good to have GRSB presence at Future of Food events to be a voice with the plant-based diet advocates. There is also opportunity to sponsor one of their webinars which would could allow for expanding GRSB efforts into new audiences.

Eisele also reported on a successful trip to Uruguay visiting with members and stakeholders in establishing a Uruguayan Roundtable.
